



## **RESOLUTION NO. 2019-149**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS AUTHORIZING A CONTRACT WITH MABAK DIRECTIONAL DRILLING, INC. AND ATMOS ENERGY CORPORATION TO PROVIDE FOR THE INSTALLATION OF A GAS SERVICE LINE FOR THE KEENAN SERVICE CENTER; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, City Administration, with the assistance on the City's construction manager, developed a scope of work for extension of a gas service line owned by Atmos Energy Corporation ("Atmos") for the Keenan Service Center Project and solicited bids for such work in accordance with applicable law; and

**WHEREAS**, having opened and reviewed the bids received, City Administration has determined that Mabak Directional Drilling, Inc. ("Mabak") has submitted the lowest most responsible bid for the requested work; and

**WHEREAS**, Atmos has approved Mabak as an authorized contractor to perform the above-described gas service line extension; and

**WHEREAS**, City Administration recommends that the work related to the installation of the gas service line be awarded to Mabak and an agreement be signed and negotiated with Atmos and Mabak to perform said work; and

**WHEREAS**, the City Council of the City of Farmers Branch, Texas finds it to be in the public interest to accept the recommendation of the City Administration.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, THAT:**

**SECTION 1.** The City Manager is hereby authorized to negotiate and execute an agreement with Atmos and Mabak in the amount of \$102,799.00 to provide the work, materials, equipment, and/or supplies to install a gas service line for the Keenan Service Center; and to negotiate and execute such changes orders to said agreement as he determines to be reasonable and necessary subject to applicable state law, city policies, and, in the event of an increase in contract price, the availability of current funds to pay such costs.

**SECTION 2.** This Resolution shall take effect immediately upon its passage.
