A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FARMERS BRANCH, TEXAS, APPROVING AN AMENDMENT TO THE DETAILED SITE PLAN FOR 12.111± ACRES OUT OF THE NOAH GOOD SURVEY, ABSTRACT NO. 520, DESCRIBED HEREIN AND LOCATED IN PLANNED DEVELOPMENT NO. 90 (PD-90) BY ADDING A SIGN PLAN; AND PROVIDING AN EFFECTIVE DATE

The Detailed Site Plan for the Property, as adopted pursuant to Resolution No. 2017-120, is hereby amended by adding Exhibit "F" to Resolution No. 2017-120 to read as set forth in Attachment 1, attached hereto and incorporated herein by reference ("Detailed Site Plan - Signs"). Signs installed on the Property on and after the effective date of this resolution shall comply with the location, type, size, and design as set forth on the Detailed Site Plan - Signs.

SECTION 2. This resolution shall become effective immediately upon its approval.




EXHIBIT "F" - DETAILED SITE PLAN - SIGNS






EXHIBIT "F" - DETAILED SITE PLAN - SIGNS








EXHIBIT "F" - DETAILED SITE PLAN - SIGNS





EXHIBIT "F" - DETAILED SITE PLAN - SIGNS




