CALL TO ORDER - STUDY SESSION (3 P.M.)

Mayor called Meeting to order at 3 p.m.

Discuss regular City Council meeting agenda items A.1 19-76

Mayor Pro Tem asked for clarification on Agenda Item I.3 (R2019-022).

Director of Public Works Marc Bentley explained the motion is to validate the emergency repairs completed. Mr. Bentley updated Council with the amount of \$167,559 requiring council to approve as amended.

Receive biannual report from the Parks and Recreation Board **A.2** 19-88

Parks & Recreation Board Member Bob Stewart updated council with the overall mission, projects, and funding resources. Mr. Stewart asked Council to provide direction on how the board should continue to proceed.

Mayor Pro Tem Norwood stated a review of the parks and their functions as previously discussed will assist Council in the next budget cycle to identify opportunities to repurpose their use.

Assistant Director Mike Mashburn stated Parks has collaborated with GIS to illustrate the population of children in relation to parks.

Director of Parks & Recreation Jeff Harting noted the Christmas Update to Council is a future agenda item.

A.3 19-92 Discuss Library Bond Education Program

Assistant City Manager Benjamin Williamson briefly presented informational material underway for the Library in a Park Bond including informational resources, property city tax impact, voting information, City events and town halls to raise awareness and educate the public.

The Council members present agreed to individual town halls as previously structured to be scheduled in April.

A.4 19-60

Receive a presentation of the Police Traffic Stop Data Analysis Report for calendar year 2018, as required by Section 2.132 of the Texas Code of Criminal Procedures

Police Chief David Hale provided a presentation on the State required report on traffic stops in 2018. He explained the State establishes certain assumption for the data collected on the 14,521 traffic stops. He noted this is a significant daily duty and supervisors review a minimum of 5 traffic stops from different officers every month. The findings of this report state the City is in full compliance with the Texas Code of Criminal Procedure, education and training of officers, public complaint processing, data collection, policy prohibiting bias based policing, and TCOLE reporting requirements.

Council Member Reyes asked if there are any parts of the city needing additional presence.

Chief Hale stated the current challenge is the on the west side with the new construction of homes and theft.

A.5 19-74 Receive the Fiscal Year 2018-19 First Quarter Financial Report

Mayor Dye stated the Council will receive this report in a future meeting.

A.6 19-86 Receive a report from Animal Services regarding the ordinance and statistics related to dangerous dogs.

Animal Shelter Manager Miguel Gauna provided a brief presentation explaining existing definitions of animals at large and dangerous animals with unprovoked attack scenarios. He also explained the current due process, appeal process, non-compliance and notifications of violations to pet owners.

City Attorney Jeffrey Cornell reviewed the City Ordinance and recommended changes such as "unprovoked attack" to "attack", "serious bodily injury" to "bodily injury" unless if defined by State Law. He stated by removing the age requirement to receive a sworn complaint to "any person" and rewording a section for the benefit public readability and comprehension. He asked Council to decide on a trial de novo or a substantial review for animal cases.

The Council agreed on a trial de novo.

A.7 19-68 Discuss agenda items for future City Council meetings

Council Member Lynne suggested an update on bulk pick up related to Community Services and notifications during the transition period.

Director of Sustainability & Health Shane Davis assured City Council a grace period is being implemented and educational material is being provided to residents to communicate the recent change.

Mayor Dye recessed for a break at 4:28 p.m.

Mayor Dye and City Manager Charles Cox complemented and presented Deputy City Manager John Land a 10 year service pin. They stated he has been a valuable asset to the City.

Mayor Dye recognized The Rotary Club and The Civic League for their efforts towards better of the Farmers Branch and surrounding cities.

J.1 R2019-13

Consider approving Resolution No. 2019-13 authorizing the City Manager to negotiate and enter into an agreement with Gallagher Construction, in an amount not to exceed \$480,000 to serve as Construction Manager for the construction of phase one of the Service Center Project and take appropriate action

Director of Fleet & Facilities Management Kevin Muenchow provided a brief presentation of the construction of phase one for the Service Center Project. The City has contracted with Gallagher Construction Company for major building construction projects since the construction of the Branch Connection in 1998. Gallagher has performed all projects with great success in bringing project to completion on-time and under budget.

Council Member Norwood stated this project is a pay as you go project and not funded by borrowing.

A motion was made by Deputy Mayor Pro Tem Bomgardner, seconded by Council Member Reyes, that Resolution 2019-013 be approved. The motion carried by the following vote:

Council Member Lynne made a motion to authorize the City Manager to negotiate and execute an amendment to the Restriction Agreement between the City and Josey Lane Crossing, LLC, relating to the development of Lot4, Block A, The Shops at Branch Crossing, to reclassify the northern 25,000 square feet of the Retail Tract as Clinic Tract and other conforming amendments thereto. Motion was seconded by Deputy Mayor Pro Tem Bomgardner.

After discussion, the Council agreed to table this item.

Deputy Mayor ProTem Bomgardner withdrew his second to the motion. Motion was withdrawn.

A motion was made by Mayor Pro Tem Norwood, seconded by Deputy Mayor Pro Tem Bomgardner, to authorize the City Manager to negotiate and execute an economic development agreement on behalf of the City and WeWork, LLC and/or its related entities to provide a grant up to \$1.00 per square foot of space leased in the building located at 13595 Inwood Road, Farmers Branch, Texas, not to exceed \$90,000, to be paid upon issuance of a certificate of occupancy with respect to such lease space; provided that WeWork LLC leases not less than 20,000 square feet of space at 13595 Inwood Road for a lease term of not less than 7 years with a lease commencement date of not later than December 1, 2020. The motion carried by the following vote:
