Consider approving Resolution No. 2017- 039 awarding unit price bids for the annual purchase of chemicals and fertilizers for the Parks and Recreation Department; and take appropriate action.

BACKGROUND:

The Parks and Recreation Department requests bids for an annual supply of chemicals and fertilizers. Bidding an annual supply increases staff efficiency and is more cost efficient than buying individual items numerous times throughout the year.

DISCUSSION:

Bid requests were advertised and sent to eight vendors. Five bids were received and opened on December 20, 2016. Vendors were notified in the specifications that the quantities were estimates and that the City may purchase adjusted quantities of each product. The low bids received met specifications on all items. The total cost of the low bid items meeting specifications is \$102,000.17.

There is \$110,500 budgeted for the annual supply of chemicals and fertilizers. The balance of that account will be utilized to purchase other fertilizers that cannot be included due to price volatility.

RECOMMENDATION:
